who is a permanent senior official of the House of Commons. The main role of his office is advising the Speaker and MPs on House procedure (the formal and informal rules of its everyday activities) and managing the Commons' departments and services. Appointed by the Crown, the Clerk has no political affiliations and is not a civil servant. He is also the Chief Executive Officer for the House of Commons Administration.

Closures are usually indicated in Portcullis, the online catalogue, and will be reviewed on request.
The Parliamentary Archives does not undertake detailed research for enquirers but can provide the names of independent researchers who do this on payment of a fee to be agreed with the enquirer. Enquiries and requests for review of closed records should be sent to the Parliamentary Archives.
