# Introduction

This booklet lists all the candidates for the election of the three Deputy Speakers

# The election will take place on Tuesday 23 July between 10am and 1.30pm in Committee Room 8.

The election is governed by Standing Order No. 2A. The candidates are listed in alphabetical order. Each entry gives the candidate's name and the side of the House they come from.

All candidates are required to sign a statement indicating willingness to stand for election. Each candidate's entry in the booklet prints any further personal statement that has been submitted by that candidate.

Constraints will be applied to the count so that of those elected:

 two candidates shall come from the opposite side of the House to that from which the Speaker was drawn, the first of whom will be Chairman of Ways and Means and the second, Second Deputy Chairman of Ways and Means;

- one candidate shall come from the same side of the House as that from which the Speaker was drawn and shall be First Deputy Chairman of Ways and Means; and
- at least one man and at least one woman shall be elected across the four posts of Speaker and Deputy Speakers.

# Dame Karen Bradley Opposition side

#### **Statement**

I have put myself forward for the role of Deputy Speaker of the House of Commons because I believe that my experience and personal qualities would contribute to keeping the chamber working effectively, assist all MPs with what can be a challenging job and help improve the public's view of Parliament.

I have been an MP for 14 years and during that time I have served as a Whip, as a Minister in three different departments and I have spent significant time on the backbenches. I have been a member of several select committees and APPGs and, during the last Parliament, I was honoured to be elected by MPs from across the House as Chair of the Procedure Committee. In that role, I was able

to help us navigate the biggest change to the way Parliament works for over 600 years during the Covid pandemic. These experiences mean that I know how many of you feel today but also how to help you make the most from your time here as an MP.

Parliament has many functions. It gives us the opportunity to represent our constituents in a unique and privileged way. It provides for debate of both national and local concerns. It makes sure that ministers are properly scrutinised, which then makes for better government decisions. But it also has a role in ensuring that the Government can deliver the manifesto on which it has been elected by the people. We saw in the 2017 to 2019 Parliament, just how damaging it can be when Parliament tries to completely block Government from delivering what the public asked it to do.

If you choose me to be one of the Speaker's deputies, I will aim to help the House achieve all those important tasks. I am grateful for the backing of colleagues from across the political divide, several of whom have been kind enough to say that my calm, approachable style will help when the Chamber can be chaotic.

# Sir Roger Gale Opposition side

#### **Statement**

Roger Gale is the former radio and television reporter, producer and director who began his broadcasting career on Radio Caroline!

He was first elected to contest the newly created North Thanet constituency in East Kent in 1983 and represented the seat until it was abolished in the 2024 boundary changes. He was then re-elected as the Member of Parliament for the new Herne Bay and Sandwich constituency on 4th July.

In the course of a long and varied career Roger has served as Parliamentary Private Secretary (PPS) to two Secretaries of State for the Armed Forces, resigning over a point of principle. He is a post-graduate of the Parliament and Armed Forces scheme and while an MP also carried out duties

as a Special Constable with the British Transport Police.

A life member of the Inter-Parliamentary Union and the Commonwealth Parliamentary Association, Roger has worked as an international election observer in many countries in Africa and in political hotspots, including the Russian Federation, Ukraine, Georgia and Armenia, throughout the wider Europe. After five years as a back-bench Member Roger became the leader of the UK delegation to the Parliamentary Assembly of the Council of Europe (the PACE) in 2015 and, having been the senior Vice-President, ended his term of office as President of the Assembly.

Roger joined Mr. Speaker's Panel of Chairs in 1997 and has presided over many significant pieces of legislation under Labour, Conservative and Coalition governments both in committee and on the floor of the House. He is now the most senior and experienced member of the Panel.

Roger first acted as a Deputy Speaker during the Queen's Speech debate in 2019. In January of 2023 he was appointed to the role of Deputy Speaker by Order of the House, a position that he held for the eighteen months until the dissolution of Parliament this year.

Roger Gale will bring experience, fairness, strict impartiality and courtesy to the position of Deputy Speaker of the House of Commons/ Chairman of Ways and Means.

Many of us have suffered severe harassment, and some of our friends are no longer with us. Parliament must have confidence that its Speakers are alert to the threats we are facing and will work tirelessly to confront them. The security of parliamentarians and the integrity of our processes would be my top priorities.

My approach is, and has always been, collaborative. I believe that every MP has the right

and duty to represent their constituents through the legislative process. I have always worked cross party, as my record bears out, recognising that some issues are bigger than party politics. As Deputy Speaker, I would work to protect and expand backbench-initiated debates. With the current makeup of the House, it is ever more important we balance the rights of MPs to represent their constituencies and hold the Government to account. I have served as a Backbencher, Chair of Westminster Hall Debates and Committee sessions as an active Member of the Speaker's Panel of Chairs. I have worked cross party on amending legislation in both Houses and served on multiple Select Committees. As a Minister I have delivered tricky legislation whilst being accessible to colleagues of all parties and led on cross party debates and motions that have secured unanimous support of all political parties. I also secured the confidence of my Conservative colleagues to be elected as Vice Chair of the 1922 Committee – a job that requires discretion and lots of time.

I have campaigned on Human rights and sexual violence against women and was nominated by NATO PA for the 'Women for Peace and Security' Award. I was runner up to Nancy Pelosi.

#### **Statement**

### My background

I was brought up in the far north of England, attending comprehensive secondary schools in Carlisle. I became a legal-aid family law solicitor and practiced for 23 years before entering Parliament in 2010, having built and led a widely respected specialist law firm.

I am proud to have been the first black female
Conservative MP and later, Minister, under David
Cameron's coalition government. I served as Justice
Minister, Minister for Women & Equalities and
Minister for Sport. During this period, I was one
of the three Ministers responsible for taking the
Marriage (Same Sex Couples) Bill through the House
of Commons.

For the last four years I have been the Prime Minister's Special Envoy for Girls Global Education within the FCDO, championing Britain's leading role in seeking to ensure every girl on the planet has access to 12 years of quality education. The work has taken me to heads of state and governments worldwide and required considerable diplomatic and political collaboration.

### What I will bring to the position

If elected as a deputy speaker my priority in the Chamber will be to ensure smooth and compliant procedure, the highest standards of respect, absolute impartiality in granting a voice to Members of all sides of the house, and fairness. My style in the chair will be respectful yet gently firm. I have no time for those who seek to belittle others and I know that giving new members as much certainty as possible with procedures and timings will be especially important.

Behind the chair I will work closely with Mr Speaker to continue his mission for modernisation and culture change. I care particularly about helping to sustain and preserve Members' family units in this unique, but often challenging, working environment. I will also help to further sharpen the focus on the well-being, security and safety of

Members, their families and staff.

I have worked with the previous Speaker on various projects, including preserving and improving the existing creche facilities for members and staff, selecting a new Serjeant at Arms and creating a parliamentary exchange programme for international students.

#### **Statement**

#### **Statement**

#### **Statement**

Our Parliament is one to be proud of, a phenomenal institution which has endured steadfastly over the centuries. Every person in this place brings something unique and our Chamber needs to empower them to champion their constituents and the causes they care about.

I can bring experience to the role of Deputy Speaker, having served on the Panel of Chairs since 2019. I have seen, from the Chair, the passion Members bring to this place, and the power we have to hold Ministers to account. Over the last 4 years in Westminster Hall and

There is a fantastic raft of candidates to choose

from in this election. All of us bring something different and all of us want to work to make sure Parliament is heard. We need to work together to make sure the issues you will champion get time and attention. I know many new colleagues will want support and encouragement. Procedures and conventions can be very different, and I want to be a Deputy Speaker who will be able to guide and advise, not interfere. You will want to do it your way, and I want to help you do exactly that.

In my time on the back benches, I have never been afraid to speak out, and recognise that on some occasions that is crucial. But the role of Deputy Speaker is absolutely not about being outspoken, it is about enabling others to get their point across. This is my opportunity to hear your voices, not for you to hear mine, and there may be many who welcome that!
