## Summary

---

I investigated an allegation that the Member had failed to register a series of overseas visits, undertaken between August 2011 and 31 December 2014.

- 5 When the Member replied to my letter initiating the inquiry, he identified seventeen overseas visits he had made between 1 August 2011 and 31 December 2014, and of those one which he should have registered in the Register of Members' Financial Interests and had not. The Member acknowledged his breach of the rules and apologised unreservedly for it. I have arranged for that entry to be italicised in the Register of Members' Financial Interests, in accordance with the usual practice.
- 10 I concluded my inquiry using the rectification procedure available to me under Standing Order No 150.

## Rt Hon Jeremy Corbyn MP: resolution letter

**Letter from the Commissioner sent to Mr Bridgen MP; Mr Jacobsz; and Mr Francois MP, 21 February 2019**

5 I wrote to you on 3 September 2018 to tell you that I had begun an inquiry into your allegations that Rt Hon Jeremy Corbyn MP had breached the House's rules on the registration of financial interests.

10 I am writing now to let you know that I have concluded my inquiry using the rectification procedure available to me under Standing Order No 150. The rationale for that decision is set out in my letter to Mr Corbyn of 4 February 2019, which is reproduced at item 17 of the enclosed written evidence.

I will notify the Committee on Standards in due course of this outcome. The matter is now closed.

## Written evidence

---

### 1. Letter from Mr Andrew Bridgen MP to the Commissioner, 14 August 2018

5 I am writing to request you investigate a serious breach of the House of Commons' Code of Conduct, relating specifically to rule of conduct number 13 and 16, by Jeremy Corbyn MP.

Over the past few days it has been widely reported that Mr Corbyn visited Tunis in September and October 2014, as a guest of the President of Tunisia. However, this trip was not declared in Mr Corbyn's entry in the Register of Members' [Financial] Interests at the time.

10 Mr Corbyn's office have declined to declare who funded this trip. Another Parliamentary Lord [name redacted], was also on the trip and has fully declared the trip in his entry in the Register, in accordance with the Code of Conduct.

You will be aware that paragraph 13 states

15 *Members shall fulfil conscientiously the requirements of the House in respect of the registration of interests in the Register of Members' Financial Interest. They shall always be open and frank in drawing attention to any relevant interest in any proceeding of the House or its Committees, and in any communications with Ministers, Members, public officials or public office holders.*

20 It is clear that Mr Corbyn has not registered this trip abroad; this raises questions over who funded the trip and how much the trip cost. It also raises questions about whether Mr Corbyn breached the Code of Conduct by not referring to his entry in the Register in debates mentioning Israel, Palestine or Tunisia.

25 I would also draw your attention to paragraph 16 of the Code of Conduct which states:

*Members shall never take any action which would cause significant damage to the reputation and integrity of the House of Commons as a whole, or of its Members generally.*

30 It is clear that Mr Corbyn's actions in attending the wreath laying ceremony, subsequently not declaring it and the following media coverage has caused significant damage to the reputation of the House of Commons and its Members.

Finally, in the defence provided by Mr Corbyn of his trip, he has broken one of the General Principles of Conduct - Openness.

As the Code states:

5 *Holders of public office should be as open as possible about all the decisions and actions they take. They should give reasons for their decisions and restrict information only where the wider public interest clearly demands it.*

Mr Corbyn has demonstrably failed this test.

The Code of Conduct for Members of Parliament is vital to ensure that people have trust in their elected representatives and it is therefore vital its contents are upheld.

10 I do hope that you will consider this case as to one which should be investigated and I look forward to hearing from you.

## 2. Letter from Mr Ryan Jacobsz to the Commissioner, 14 August 2018

15 My letter refers to a foreign trip undertaken by Labour MP Jeremy Corbyn in 2014. I refer to chapter 1, category 4 and sections 31 and 33 respectively below. I reference the applicability of each relevant section to the issues around this possible breach - my notes in bullet points and red text. There is a realistic possibility that Mr Corbyn breached parliamentary rules but it is only the Commissioner who can determine this through further probing on this matter.

### Chapter 1: Registration of Members' Financial Interests

20 Category 4: Visits outside the UK

#### Threshold for registration

25 31. Members must register, subject to the paragraphs below, any visits to destinations outside the UK where the cost is over £300 if that cost is not wholly borne by the Member or by UK public funds. They must also register multiple visits funded by the same source if taken together these visits have a value of more than £300 in a calendar year.

- 30 • Corbyn's own account, noted in his article for The Morning Star newspaper, of his trip to Tunisia states that he was in the country on 1 October 2014 when "wreaths were laid at the graves of those who died on that day and on the graves of others killed by Mossad agents in Paris in 1991". He is also reported to have attended a conference on 30 September 2014 as part of the same trip.

- While it is possible Corbyn paid for the trip himself, an entry in the Lords Register of Interests suggests it may have been a trip paid for by "The President of Tunisia"... this is based on an entry registered by Conservative Peer Lord [redacted] "A visit to Tunisia" which matches the dates of Corbyn's trip and which matches Corbyn's statement that the visit was "at the invitation of the President of Tunisia". There is no suggestion that [the Lord] joined Corbyn at the wreath-laying.

#### Requirements for registration

#### 33. Under this category Members must register:

- 10 Any travel or hospitality received in the course of a visit outside the UK, if it relates in any way to their membership of the House or to their parliamentary or political activities including:

a) international and other travel;

b) hospitality, including hotel or other accommodation, and meals;

- 15
- The travel or hospitality received - of course without probing by the relevant authority - the Standards Commissioner, we won't know the exact details of this;
- 20
- The nature of the ceremony (attended in Tunisia by Mr Corbyn) can only reasonably be viewed as relating to Mr Corbyn's political activities; Mr Corbyn has a long and well known history of political campaigning for the Palestinian liberation cause and this ceremony was centred on that; that is undisputed.

#### **3. Letter from Mr Mark Francois MP to the Commissioner, 18 August 2018**

- 25 I am writing to alert you to a potentially serious breach of the MPs' Code of Conduct by Jeremy Corbyn MP and to ask that you investigate.

30 Over the past week it has become clear that Mr Corbyn has on a whole host of visits that have not been declared in the Register of Members' [Financial] Interests. This follows on from earlier reports about Mr Corbyn personally, in articles in the Morning Star newspaper.

The visits are as stated below:

- b) 13 March 2014 - Morocco. Mr Corbyn visited Morocco with War on Want.

- c) 3 June 2012 - Greece. Mr Corbyn says that he visited Alexis Tsipras and attended a rally.
- d) 7 December 2011 - Germany. Mr Corbyn attended a conference organised by protestors against Petersburg II and the No to NATO Network.
- 5 e) 25 August 2011 - Mexico. Mr Corbyn attended a Special Congress of the Democratic Revolutionary Party in Mexico.
- f) 28 February 2011 - Tunisia, Mr Corbyn visited Tunis where his first port of call was a "joyous rally celebrating the release of prisoners".
- 10 g) 11 February 2011 - Lebanon. Mr Corbyn attended a delegation to commemorate the massacres at Sabra and Shatila.
- h) November 2010 - Israel. Mr Corbyn visited the West Bank and Israel with a delegation from Middle East Monitor.
- i) 2 May 2007 - Austria. Mr Corbyn attended a conference on the nuclear Non-Proliferation Treaty in Vienna.
- 15 j) 10 January 2007 - Israel and Palestine. Mr Corbyn visited Palestine and Jerusalem.

Mr Corbyn has apparently not declared these trips - raising questions about how much they cost, who funded them or if he has paid for them himself and if they should have been declared.

20 Paragraph 13 of the Code of Conduct reads:

25 *Members shall fulfil conscientiously the requirements of the House in respect of the registration of interests in the Register of Members' Financial Interest. They shall always be open and frank in drawing attention to any relevant interest in any proceeding of the House or its Committees, and in any communications with Ministers, Members, public officials or public office holders.*

The Code of Conduct is designed to promote the public's trust in their Member of Parliament and it is therefore essential that all Members adhere to its rules.

Given this, I would ask that you conduct an investigation into these trips and whether they were properly registered in accordance with the Code. To assist your inquiries, I have included copies of all relevant articles by Mr Corbyn himself.<sup>1</sup>

5 **4. Letter from the Commissioner to Rt Hon Jeremy Corbyn MP, 3 September 2018**

10 I would welcome your help with allegations I have received from Mr Andrew Bridgen MP, Rt Hon Mark Francois MP and Mr Ryan Jacobsz about your compliance with the House of Commons' rules on the registration of financial interests. I enclose a copy of each of their letters (with enclosures) for information.

The scope of my inquiry

15 In light of these letters and information already in the public domain, I have decided to begin an inquiry. The scope of the inquiry will be, in essence, to establish whether you acted in breach of the House of Commons' Code of Conduct for Members by not registering in the Register of Members' Financial Interests overseas visits which you are reported to have made between 2011 and 2014.

20 You will see that Mr Francois referred to nine overseas visits, about which you had written newspaper articles. I may not generally investigate allegations concerning events that occurred more than seven years earlier. I may do so exceptionally, only after consulting the Committee on Standards. I have decided that the evidence provided by Mr Francois does not justify that exceptional step and will advise him accordingly. The scope of my inquiry does not, therefore, include the last six of the visits listed by Mr Francois.

The relevant rules and guidance

25 The Code of Conduct

Paragraph 12 of the 2005 edition of the House of Commons' Code of Conduct for Members said:

30 *"In any activities with, or on behalf of, an organisation which a Member has a financial relationship, including activities which may not be a matter of public record such as informal meetings and functions, he or she must always bear in mind the need to be open and frank with Ministers, Members and officials."*

2. Paragraph 16 of the 2005 Code of Conduct for Members said:

5 *"Members shall fulfil conscientiously the requirements of the House in respect of the registration of interests in the Register of Members' Interests and shall always draw attention to any relevant interest in any proceeding of the House or its Committees, or in any communications with Ministers, Government Departments or Executive Agencies."*

An amended version of the Code of Conduct for Members was approved by the House on 12 March 2012. Paragraph 13 of the amended Code said:

10 *"Members shall fulfil conscientiously the requirements of the House in respect of the registration of interests in the Register of Members' Financial Interests. They shall always be open and frank in drawing attention to any relevant interest in any proceeding of the House or its Committees, and in any communications with Ministers, Members,*  
15 *public officials or public office holders."*

The Guide to the Rules relating to the conduct of Members

The 2009 Guide to the Rules relating to the conduct of Members (the Guide) as revised in 2010 was in force between 2011 and 2014. Chapter 1 of the Guide contained the detailed rules concerning the registration of financial interests.

20 Paragraphs 46 to 49 of the Guide set out the rules concerning the registration of "Overseas visits". This registration category was introduced as follows:

25 *"With certain specified exceptions, overseas visits made by the Member or the Member's spouse or partner relating to or in any way arising out of membership of the House where the cost of the visit exceeds one per cent of the current parliamentary salary and was not wholly borne by the Member or by United Kingdom public funds."*

30 During the period in question Members were required to register any visit not wholly funded by an exempt source, if its value exceeded £660 even if more than one funder had met the costs. Visits with a value of £660 or less would also need to be registered if the same source had paid for other visits in that calendar year and the total value of these exceeded £660.

35 Chapter 2 of the Guide explained the circumstances in which Members should make a declaration (an ad hoc disclosure) of a relevant financial interest. The main purpose of declaration is described as follows in paragraph 8 of the introduction to the Guide:

5            *"to ensure that Members of the House and the public are made aware, at the appropriate time when a Member is making a speech in the House or in Committee or participating in any other proceedings of the House, of any past, present or expected future financial interest, direct or indirect, which might reasonably be thought by others to be relevant to those proceedings."*

10           The main purpose of the Register of Members' Financial Interests was defined in the introduction to the Guide as *"to give public notification on a continuous basis of those financial interests held by Members which might be thought to influence their parliamentary conduct or actions"*. It is the responsibility of Members to notify changes in their registrable interests within four weeks.

Chapter 3 of the Guide explained the prohibition on "Lobbying for Reward or Consideration".

I enclose a copy of chapters 1, 2 and 3 of the Guide for your reference.

15    Other matters

As you will see from the enclosures, Mr Bridgen has also alleged that your conduct was in breach of paragraph 16 of the (2012) Code of Conduct for Members, which said:

20            *Members shall never undertake any action which would cause significant damage to the reputation and integrity of the House of Commons as a whole, or of its Members generally.*

25           Mr Bridgen's letter does not provide evidence to justify an inquiry into that allegation. However, should any matter arise during the course of my inquiry which might engage that rule, I will draw that to your attention and give you the opportunity to comment.

Next steps

I would welcome your comments on the allegations that you have acted in breach of the rules by not registering overseas visit.

Specific questions about each visit

30           Please provide the following information about any unregistered overseas visits which related to or in any way arose out of your membership of the House between 1 August 2011 and 31 December 2014. To assist you in identifying them, I enclose a copy of your register entries between 2011 and 2014.

1. The exact dates of the visit.

2. Whether you attended alone or were accompanied by a guest or staff member.
3. Whether the visit was funded, in part or wholly, by anyone other than you or by UK public funds.
  - 3(a) If it was, please say by whom the costs of the visit were met.
- 5 3a(i) If there was more than one funder, please explain who funded which of the costs.
- 10 4. The total value of the visit (the value should include all associated costs, e.g. flights, overnight accommodation, internal transfers, all hospitality/food provided and any security arrangements, and any costs in respect of a guest/staff member which were also met by the funder(s) and should be calculated on the basis of market values at the time.)
  5. Please provide a breakdown of the elements included in the calculation.
    - 15 5(a) If you do not have and cannot obtain details of all the elements, please provide estimates, with any supporting evidence you have and an explanation of how the estimated value has been arrived at.
  6. Whether you considered registering the visit in Category 6 of the Register at the relevant time.
  7. If you did give the matter consideration, please describe the factors which led you to conclude that the House's rules did not require registration.
  - 20 8. Whether you consider now that there was any occasion, either in the period between when you first expected to make the visit and the expiry of the twelve-month period after the visit, that the rules of the House (chapter 2 of the Guide) would have required you to make a declaration of interest.
  - 25 9. If there was such an occasion or occasions, please describe the factors which led you to conclude that the House's rules did not require you to do so.
  - 30 10. Whether you have, at any time when the provisions of paragraphs 89 to 102 of the Guide to the Rules would have been relevant, had cause to consider whether your participation in any proceedings of the House might be affected by those rules. In other words, whether you have lobbied on behalf of any person or organisation which funded your visits or their clients, seeking an exclusive benefit for that person or organisation.
  11. If you have, please describe the factors which led you to conclude that the House's rules did not restrict your participation

I draw your attention to paragraph 100(d) of the Guide, but should also mention paragraph 99(7), which appears to be contradictory.

5 It would be most helpful to receive as much evidence as possible to support your answers to the above questions with your response to this letter. I would be happy to receive any other information and evidence that you think might assist my understanding of this matter.

As a matter of courtesy, I should say now that I expect to make enquiries of the relevant House authorities, including the Registrar, in due course. I may also contact relevant third parties. If I do so, I will share that correspondence with you.

#### 10 Important Information

I enclose a copy of the *Commissioner's Information Note*,<sup>5</sup> which sets out the procedure for inquiries. I am writing to Mr Bridgen, Mr Francois and Mr Jacobsz to let them know that I have decided to begin an inquiry into this matter.

15 Following the decision taken by the House on 19 July 2018, I will not publish the fact that I am conducting an inquiry into an allegation into an alleged breach of the Code of Conduct. My office will not comment on any aspect of the inquiry to third parties. They will answer direct factual questions about the processes I follow and the standards system more generally but will neither confirm nor deny that I have begun an inquiry.

20 As you will be aware, my inquiries are conducted in private. Following the decision taken by the House on 19 July 2018, I will not publish the fact that I am conducting an inquiry into an allegation into an alleged breach of the Code of Conduct. My office will not comment on any aspect of the inquiry to third parties. They will answer direct factual questions about the processes I follow and the standards system more  
25 generally but will neither confirm nor deny that I have begun an inquiry.

This letter and any subsequent correspondence between us in connection with this inquiry is protected by parliamentary privilege. It should be kept confidential until the outcome of my inquiry is published. (I have made a similar request of each of the complainants.) All the relevant evidence, including our correspondence, will  
30 be published when I have concluded my work.

While I do not, at this stage, know whether it will be necessary to interview you about this matter, it would be open to you to be accompanied at any such interview. I am, of course, very happy to meet with you at any stage if you would find that helpful.

#### 35 Action

I would be grateful to have your response to this letter as soon as possible. I would usually ask for a reply within a week or two. However, given the number of questions in respect of each visit and the amount of time that has passed, I hope it is reasonable to ask for as full a reply as possible by no later than 3 October 2018.  
5 Please let me know before that date if you think more time is required.

**5. Letter from Rt Hon Jeremy Corbyn MP to the Commissioner, 10 October 2018**

10 Thank you for your letter of 3 September 2018 and for the opportunity to respond to the allegations of Mr Andrew Bridgen MP, Mr Ryan Jacobsz and the Rt Hon Mark Francois MP.

Requirement of openness

15 You have referenced in your letter paragraphs 12 and 13 of the 2005 House of Commons' Code of Conduct for Members (the Code) and the Guide to the Rules relating to the conduct of members 2009 (the Guide). The purpose of these paragraphs is to ensure transparency about the interests of members, in particular their financial interests. Mr Bridgen MP also references the general principle of openness set out at paragraph 7 of the Code: " *Holders of public office should be as open as possible about all the decisions and actions that they take. They should give reasons for their decisions and restrict information only when the wider public interest clearly demands.*"  
20

25 As a general point I have always sought to be open and transparent throughout my 35 years as a parliamentarian. I have used my privileged position as an MP to work, among other things, in support of human rights, peaceful and just resolutions to international conflicts, including the Israel-Palestine conflict, and efforts to bring about a more stable and safer world through nuclear disarmament. I have been open and honest about my work on these issues, have consistently spoken in the House on such matters and have made reference to relevant domestic and overseas visits and events, as well as any work conducted on behalf of non-governmental  
30 organisations. I have also regularly written and spoken about my work to tackle such issues in the media, as the Morning Star newspaper articles referred to by the Rt Hon Mark Francois MP demonstrate.

35 I represent a diverse and multicultural inner London constituency and I have always had a significant interest in international affairs. In the period covered by this investigation, I was Chair of the APPGs on the Chagos Islands, Mexico, Western Sahara, the African Great Lakes Region, and I was Vice Chair of the APPG on Human Rights for over 20 years. In line with my wide-ranging interests in international affairs, I have made numerous trips overseas throughout my time as an MP. These have often been at short notice, representing a significant undertaking for a  
40 backbench Member of Parliament with minimal staff. But at no point did I ever seek to be anything other than open about them. In fact, as my writing and speaking about

my trips demonstrates, it was quite the reverse: I often wrote about my trips specifically in order to publicise the issues and causes to which the trips related for the benefit of my constituents and the wider public.

#### Specific questions about unregistered overseas visits

- 5 Enclosed with this letter are tables showing the answers to the 11 specific questions you raised in your letter in relation to unregistered overseas visits made between the period 1 August 2011 and 31 December 2014. Also enclosed is the relevant supporting evidence.

- 10 As I believe the tables demonstrate, as a matter of routine I take lower cost flights and stay in lower cost hotel rooms wherever possible. I often have not stayed the full time allotted for events due to the pressures of my parliamentary work. I frequently either wholly or in-part self-funded visits central to my work promoting human rights and nuclear disarmament.

- 15 Please note, I have not included in the tables visits undertaken on behalf of the Inter-Parliamentary Union due to their exemption under para. 47(iii) of the Guide<sup>1,2</sup> Self-funded family holidays have also not been included, except for the August 2011 holiday to Mexico specifically referred to by Mark Francis MP. There may additionally be some small hospitality costs missing from some of the entries as a result of conference organisers providing lunch or dinner for attendees. However, I  
20 have included estimates of such costs where the overall value of the visit is near the £660 threshold. If you require further details about any referenced visits, please let me know and I will respond at the earliest opportunity.

#### Registration in Register of Members' Financial Interests

- 25 I have routinely considered the requirement to register overseas visits. As is clear from the table, the vast majority of my visits during the period in question fell below the £660 threshold required for registration (category 6). Others were also exempt under para.47(i) of the guide as they were paid for by UK public funds under the IPSA system or because the cost of the visit was wholly borne by me and so exempt under the wording of category 6.

- 30 There is one visit that should have been registered, but my office and I omitted to register, for which I take full responsibility: my April 2014 trip to the UN in New York to attend the Non-Proliferation of Nuclear Weapons Treaty Preparatory Committee, funded by the Campaign for Nuclear Disarmament (CND). The failure to register this visit was a complete oversight for which I apologise unreservedly. I can  
35 only imagine that we overlooked registration in this instance due to an incorrect assumption that the trip would be below threshold. Most of my overseas trips and

visits have been inexpensive and under the threshold for declaration. Often, they have been self-funded in part or wholly.

#### Declaration of relevant financial interest

5 In addition to registering overseas visits, I also routinely consider whether I am required to declare in debate or other proceedings, "*any past, present or expected future financial interest, direct or indirect, which might reasonably be thought by others to be relevant to those proceedings*"<sup>3</sup>

It is self-evident that trips that are self-funded cannot give rise to a relevant financial interest.

10 Paragraph 74 of the Guide states "*It is the responsibility of the Member, having regard to the rules of the House, to judge whether a financial interest is sufficiently relevant to a particular debate, proceeding, meeting or other activity to require a declaration. The basic test of relevance should be the same for declaration as it is for registration of an interest; namely, that a financial interest should be declared if it might*  
15 *reasonably be thought by others to influence the speech, representation or communication in question.*"

In relation to overseas visits I have not funded personally, each has been conducted with a view to furthering broad overarching issues such as human rights, conflict resolution and/or nuclear

20 disarmament. Given the nature of these issues, and the longstanding principles and position I hold in relation to each of them, it cannot reasonably be thought that the hospitality I have received has influenced my position in relation to proceedings on these topics. Furthermore, at no point have I participated in proceedings that have focused on the specific organisations that have funded my overseas visits.

#### 25 Lobbying

I have also not engaged in lobbying in relation to any of my overseas visits.

I have used my overseas visits only in relation to raising human rights concerns, advocating for a just and peaceful end to conflicts and bringing about nuclear  
30 disarmament. I have not sought any exclusive benefit either for the funders of those visits, or for any of the funders' clients.

#### Tunis 2014 visit

Given the focus of allegations on my visit to Tunis in 2014, I would like to expand on the nature of that visit, and my conduct in relation to it. I was invited by the Tunisian

Presidency and the Council for European Palestinian Relations (CEPR) to attend an international conference in Tunis on the 'Monitoring of the Palestinian Political and Legal Issue, in light of Israel's aggression on Gaza'. The conference was funded by the Government of Tunisia.

5 I arrived in Tunis late on the evening of 29 September 2014, arriving after dinner, and stayed 2 nights in the hotel. I travelled to Tunis airport on the evening of 1 October 2014 to catch a 2:30am flight back to the UK (via Frankfurt) on 2 October, arriving in London at 7:10am.

10 As with all my trips I undertook a routine consideration of whether or not the trip would need to be registered in line with the Rules of Conduct: this is why I emailed my staff to specify that costings of the trip would need to be below £600.003 or be registered.<sup>4</sup>

15 In this instance my staff and I believed that the costs of the trip would be below the relevant £660.00 threshold, which is why the trip was not registered. Indeed, until recent press coverage focused on this trip I had no reason to believe that the cost was above the threshold. Since the publicity around the trip my staff and I have tried to find proof of the actual cost of the trip. To date, this has not been possible.

20 In lieu of the actual cost, I have obtained today's market rate price for the flights and hotel which it must be stressed do not take account of the block booking discount which would have been obtained at the time by the Tunisian presidency. The flights were four years ago, and today's market rates are likely to be higher than they were then. These estimates are therefore unlikely to represent the actual cost at the time, which I believe would have been under the £660.00 threshold.

25 I note that the letters from my colleagues refer to the fact that Lord [name redacted], who also attended the event, registered his visit. The register states that he stayed 3 nights, therefore his costs were likely to differ from mine and the rules relating to the House of Lords are also different. In addition, Lord [name redacted] also attended the event and did not register any interest. I understand that the House of  
30 Lords rules at the time required registration for a trip over £500.00 and the different approaches taken by Lords [2 names redacted] are consistent with my belief and estimation that the trip cost under £660.00.

As regards declaring an interest, I do not believe the hospitality received by the Tunisian Government could reasonably be considered relevant to any proceedings I participated in.

35 The Israel-Palestine conflict is a geopolitical issue of enormous breadth and importance. Over the years I have attended numerous events and conferences, in the UK and overseas on this issue. My longstanding pursuit of a just and peaceful

solution to the conflict is well-known, as is my support for victims of human rights violations in the context of the conflict. The hospitality received by attending this two-day conference funded by the Tunisian government cannot reasonably be thought to have influenced my position in relation to proceedings on these topics.

- 5 Furthermore, the receipt of hospitality is too remote from the general question of Israel-Palestine to generate a requirement to declare it in all proceedings on the issue. An obligation to do so would be unworkable and absurd.

In addition, as far as I am able to ascertain, I have not spoken in any proceedings on Tunisian affairs, either in the immediate wake of the 2014 visit or since.

- 10 I can also confirm that I have never engaged in any lobbying to secure an exclusive benefit for the Tunisian Government or its clients, or for CEPR.

- As mentioned in your letter, Mr Bridgen MP also alleges breaches of para.16 of the 2012 Code of Conduct for Members in relation to my participating in a wreath-laying ceremony. For the sake of clarity, while in Tunis, I visited the Palestine National Cemetery in Tunisia to honour the victims, many of whom were civilians, of the 1985 Israeli airstrike on the PLO's headquarters. The international community, including the UN Security Council, condemned the attack as illegal under international law.<sup>5</sup> Any attempt to stigmatise my attendance at the ceremony as a breach of paragraph 16 is entirely misconceived.
- 15

- 20 I hope the above answers any concerns you may have. Please let me know if you have any additional questions or require further information.

#### **6. Letter from the Commissioner to the Registrar of Members' Financial Interests, 18 October 2018**

I would like to ask for your advice on a matter concerning Rt Hon Jeremy Corbyn MP and the registration of his financial interests.

- 30 I am investigating whether Mr Corbyn has acted in breach of the relevant rules of conduct by omitting to register a number of overseas visits allegedly funded by third parties between 2011 and 2014.

I enclose a copy of the correspondence I have exchanged with Mr Corbyn. As you can see, Mr Corbyn has provided me with the details and estimated costs of 17 overseas trips he made during that period.

5 Mr Corbyn has told me that seven of those visits were entirely self-funded (trips 3, 5, 7, 10, 11, 12, and 15), one was wholly funded by IPSA (trip 14) and two more (trips 1 and 13) were paid for through a combination of UK public funds (IPSA) and Mr Corbyn's own resources.

As you can see, Mr Corbyn has provided the estimated costs, with supporting evidence, for all 17 trips.

10 It would be helpful to know

- what advice the Registrar would have given Members at the time about the registration of visits partially funded by a third party and partially self-funded; and
- 15 • whether you would have advised Mr Corbyn to have registered any of the other ten visits in the Register of Members' Financial Interests if he had consulted you at the time.

3. Any other comments you may wish to make would be most welcome. It would be very helpful to have your response to this letter within the next two weeks.

20 **7. Letter from the Commissioner to Rt Hon Jeremy Corbyn MP, 18 October 2018**

Thank you for your letter of 10 October. The information and supporting evidence you have provided is very helpful.

25 In my letter of 3 September, I said that I expected to consult the Registrar in due course. I enclose, for information, a copy of my letter to Mrs Wood seeking her advice. I will give you an opportunity to comment on her reply before I make any decisions.

**8. Letter from the Registrar to the Commissioner, 6 November 2018**

30 Thank you for your letter of 18 October. You ask

1. What advice the Registrar would have given Members at the time about the registration of visits partially funded by a third party and partially self-funded; and

2. Whether, if Mr Corbyn had consulted us at the time, we would have advised him to register any of the other ten visits which were not entirely self-funded in the Register of Members' Financial Interests.

5 Mr Corbyn has provided you with information about 17 visits outside the UK which he undertook between 2011 and 2014. Seven of these were self-funded, and he would therefore not have needed to register them. I have considered the remaining visits below, basing my advice on the information provided, and using Mr Corbyn's numbering system. I recognise that the figures Mr Corbyn has provided are often estimates, so if further information should become available I would want to revise  
10 this advice.

Visits partially funded by a third party and partially self-funded

15 Under the current rules MPs have to register foreign visits if their value exceeds £300 but before the 2015 General Election the threshold stood at over 1% of an MP's salary (over £660 from 2010 to 2015). I have no evidence that, under the pre-2015 rules, the registration team would have advised a Member to register a visit if it was partly self-funded, when the costs met by a third party (or third parties) did not exceed the relevant threshold. I cannot find any visits of this sort recorded in the Registers of the time.

The remaining ten visits

20 Visit no 8, to Geneva

This visit was partly funded by the CND (to a value of £400) and partly self-funded. As explained in the previous paragraph, I do not believe that, on the basis of this information, - even if the total costs exceeded £660 - we would have advised Mr Corbyn to register this visit.

25 Visits number 1, 13, 14 & 16

The following four visits were exempt from registration under paragraph 47(i) of the 2009 Guide to the Rules, because they were funded by the Government, Parliament or an international institution to which the UK belongs:

- Visit no 1 (partially funded by IPSA and partly self-funded);
- 30 • Visit no 13 (partially funded by IPSA and partly self-funded);
- Visit no 14 (funded by IPSA); and
- Visit no 16 funded by the European Parliament.

Visit no 6, to New York

Mr Corbyn has already told you that he recognises he ought to have registered his visit to New York which was funded by CND to the value of £859. I agree with this, and we would have advised registration at the time. The value of the benefit he received was in excess of £660, the threshold for registering visits.

5 Visits numbered 2,7,4 and 9

10 If an MP reports that they have made a foreign visit whose estimated value falls just below the level at which it would need to be registered, we would often point out that if the MP had received further benefits, in addition to those mentioned to us, they might need to register the visit. I have set out below the advice I consider we are likely to have given in respect of each of these visits.

15 Visit no 7: Morocco and Western Sahara from 13 to 17 February 2014 (costs of £565 met by the Western Sahara Campaign): We pointed out, when contacted in March 2014, that this fell below the threshold for registration on the assumption that Mr Corbyn had not received benefits in addition to the flight and hotel costs included in the £565.

20 Visit no 2 to Tunisia from 29 September to 1 October 2014 (costs estimated at £656 met by the Tunisian Government): I believe that, if we had been advising on this visit in 2014, on the basis of the figures now provided, we would probably have asked if Mr Corbyn had received any additional benefits. We might for example have asked:

- 20
- Did you take a staffer or guest with you at any point on the visit?
  - Did you receive any other hospitality which was not provided by the main donor, such as at a formal dinner?
  - Did you receive any ancillary benefits which are not included in the figures supplied, for example, visas, airport transfers, day trips or local taxis?
- 25

If the answer to any of the above was yes, this would increase the value assigned to the visit, which could then require registration. We might also have asked if Mr Corbyn had made other visits at the expense of the Tunisian Government in 2014, as this too could have meant the visit had to be registered.

30 Visit no 4 to Basel from 4 to 5 July 2014 (costs estimated at £498 met by Parliamentarians for Nuclear Non-Proliferation and Disarmament): I believe that, if contacted in 2014 on the basis of the information now provided, we might perhaps have asked about any additional benefits received. But the value is well below £660 and I am not certain we would have done so.

35 Visit no 9 to Brussels from 5 to 6 July 2012 (costs of a Eurostar ticket priced between £58 and £318 met by the Tunisian Government: I do not believe we would have

asked further about this visit, if we were told that the Tunisian Government paid only for a return Eurostar ticket. Assuming the maximum price was £318, this falls far below the registration threshold.

Other parliamentarians making these visits

- 5 I have checked past Registers to see if anyone else had registered the visit to Tunisia in September/October 2014. No MPs have registered this visit. Mr Corbyn has pointed out that two Peers also made this visit. One has registered the visit and one has not, but since the registration threshold for Peers was lower than that for MPs, and Peers are not required to register the exact value of the benefits provided, this  
10 does not throw any light on the value of the benefits Mr Corbyn received, even assuming that his visit was of the same length.

I have checked the Members' Register to see if any other MP registered the February 2014 visit to morocco and the Western Sahara; but none have done so.

- 15 Finally, I have checked the APPG Register to see if the APPG on the Western Sahara had itself registered its visit of February 2014, as I would have expected if the total value of the benefits which its members received from the Western Sahara Campaign in the course of this visit was £1,500 or more. This visit does not however appear on the APPG Register. I conclude that either the value of these benefits fell below the £1,500 threshold, or else the registration was overlooked.

- 20 Please let me know if you need anything else.

**9. Letter from the Commissioner to Rt Hon Jeremy Corbyn MP, 15 November 2018**

- 25 When I wrote to you on 18 October 2018, I said that I was seeking advice from the Registrar of Members' Financial Interests. I have now received her reply to my letter and a copy is enclosed for your information.

Overseas trips which did not require registration

- 30 As you can see the Registrar has considered the circumstances of each of the 17 overseas visits you told me about in your letter of 10 October. Seven of those visits did not require registration because they were self-funded.

- 35 The Registrar has told me that she has found no evidence that Members would, at the relevant time, have been advised to register overseas visits which had been partially self-funded if the third-party contribution to the funding did not exceed the relevant threshold. On that basis, she does not believe the Registration team would have advised registering CND's contribution to your trip to Geneva (no 8 on your list) and I accept that advice.

5 The Registrar has advised me that overseas visits which were self-funded and partially funded by Government, Parliament or an international institution to which the UK belongs would also not have required registration. Visits numbered 1, 13, 14 and 16 on your list would also not have required registration on the basis of the information you have provided.

Your visit to Brussels in July 2012 (no. 9 on your list) was, according to the information provided, well-below the threshold for registration and this visit would not, therefore, have required registration.

#### Overseas visits which did require registration

10 You identified one visit (to New York) which CND partially funded which, because their contribution exceeded the then threshold of £660, should have been registered at the time. You have acknowledged your responsibility for this omission and you have apologised unreservedly.

15 The failure to register this overseas visit at the time has put you in breach of paragraph 13 of the then Code of Conduct for Members.

#### More information required

20 The Registrar has explained that she and her team would generally draw to the attention of Members seeking advice about visits valued at an amount close to the threshold that any additional incidental benefits would need to be taken into account. She has kindly considered the detailed advice she would likely have given in respect of such visits. She has also summarised her own research, which may be of some assistance to you.

25 I have already acknowledged that, at this distance in time, it may be difficult to provide precise figures. However, I imagine it would be possible to answer some of her questions by reference to contemporaneous diary records, etc. I would, therefore, be grateful if you would review your records concerning visits numbered 2 and 4 on your list to see if you can answer the questions she believes would have been posed at the time.

30 For completeness, I would be grateful if you would also review any records you have relating to visit numbered 7 on your list in light of the Registrar's examples of the additional benefits which might be included when calculating the value of overseas visits.

#### Declaration

35 If on further investigation you identify additional costs that might have put one or more of your overseas visits over the registration threshold, please look again at

whether you should have, on any occasion, make a declaration in respect of that visit/those visits.

#### Next steps

- 5 Once I have this information, I hope to be able to decide how to conclude this inquiry. Please let me have a full response as soon as possible and no later than 29 November 2018

#### **10. Letter from Rt Hon Jeremy Corbyn MP to the Commissioner, 28 November 2018**

Thank you for your letter of 15 November 2018 enclosing the Registrar's response to you.

- 15 Requested information

You have stated that you have various follow-up questions, I have set these out below in relation to each of the trips concerned together with my answers.

As requested, I have checked my contemporaneous diary records, and have been through my other records again.

- 20 Visit 2 (Tunis)

1. Did you take a staffer or guest with you at any point on the visit?

No

2. Did you received any other hospitality not provided by the main donor, such as at a formal dinner?

- 25 No, my understanding is, as previously stated, that all hospitality was provided for by the Tunisian Government.

3. Did you receive any ancillary benefits not included in the figures supplied, for example visas, airport transfers, day trips or local taxis?

My previous response included estimated costs for flights, accommodation, airport transfers and food (Breakfast, lunch, coffee and dinner on both days) and a further review of my records adds nothing new here. The organisation behind the conference no longer exists and there are therefore limited records in my possession. It may be that I have over-estimated for food as the conference lasted only one day (see agenda sent with my previous response) and it is likely that I covered my own lunch and dinner costs on the second day.

I routinely pay for entry visas at the airport and I don't recall or have any record of any other ancillary costs, such as formal dinners or taxis. If there were any, I would have paid them myself as I usually do. Indeed formal dinners are rare events on the human rights excursions I have participated in. Funding is almost always limited and always very carefully prioritised. This trip was a little over two days in total and did not include any day trips.

4. Did you make any other visits at the expense of the Tunisian Government in 2014?

15 No

Visit 4 (Basel)

1. Were any additional benefits received?

Enclosed with his letter is the program for the OSCE Forum. This shows that two lunches, two coffee breaks and one reception were provided as part of the conference. However, my travel tickets (sent with my previous response) show that I arrived late on Friday 4 July and left early evening on 5 July. Consequently, I will have received one lunch and one coffee break at the expense of the conference organisers, the OSCE Forum. In addition, there was a visit to the Peace Pole by bike. I cannot recall whether I paid for the bike hire myself or whether this was paid for by the conference organisers. I don't know the precise costs of these benefits but I believe a generous amount would be approximately £60. All other costs, such as airport transfers, internal transport and food, were self-funded and no visa was required. No formal dinners were provided and no day-trips took place.

Even with those additional benefits accounted for, my costs were well below the threshold for registration. In any event, I believe this visit would have been exempt under paragraph 47(iii) of the Guide to the rules relating to the conduct of Members 2009, which provides that visits undertaken under the auspices of the OSCE Parliamentary Assembly are exempt.

Visit 7 (Western Sahara)

35 1. Were any additional benefits received in addition to the flight and hotel costs?



5 I was provided with one buffet lunch by the Governor of a province of occupied Western Sahara. It is difficult to estimate what the cost of this would have been per person but, given local prices, I believe it is unlikely to have been more than £30 per person. Given the limited funds of the Western Sahara Campaign, I believe I paid for all other costs myself, including airport transfers, internal transport and food. I don't believe I required a visa. No formal dinners and no day-trips took place.

10 In light of the above, I continue to believe these trips fell below the relevant threshold for registration at the time. However, as previously stated, if you decide otherwise, I am of course willing to make the necessary notification of an alteration to the register.

I believe this answers your questions (most of which had already been dealt with in our previous estimates).

Please note I have now registered the 2014 Non Proliferation Treaty Review (NPT) trip (no 6) with the Registrar, unreservedly apologising for this oversight.

#### **11. Letter from the Commissioner to the Registrar, 10 December 2018**

I shared your letter of November with Rt Hon Jeremy Corbyn MP and, he has now provided some additional information about some of his overseas visits. I enclose a copy of his letter.

20 I would be grateful if you would review the original material and your advice to me in the light of this additional information. Please let me know whether you think it is likely you would have advised registration of any visits not now included in the Register. As you will be aware, Mr Corbyn recently added to the Register the details of his trip to New York in April 2014.

25 It would be helpful to have your advice by 19 December 2018 if possible.

#### **12. Letter from the Commissioner to Rt Hon Jeremy Corbyn MP, 10 December 2018**

30 Thank you for your letter of 29 November 2018, providing additional information about your overseas visits. I have today written to the Registrar to ask about the advice she would have given you in light of that additional information and the evidence you submitted in response to my initial enquiry.

Thank you also for acknowledging that your visit to New York in April 2014 should have been registered sooner, and your apology for the delay in doing so. I enclose a

copy of a letter I have today sent to Mr Andrew Bridgen MP, who submitted an allegation based on your recent registration of that visit.

I will write to you again as soon as I have the Registrar's reply.

**5 13. Letter from the Registrar to the Commissioner, 18 December 2018**

Thank you for your letter of 10 December, with which you enclosed one from Mr Corbyn.

Mr Corbyn has now registered the visit he made to the US from 25 to 29 April 2014 (Trip 6).

- 10 I still have some questions about other visits. These arise from the receipts and estimates submitted earlier and from Mr Corbyn's latest letter. I think it would be helpful to resolve these even though they concern matters of detail. I have listed my questions below so that you can pass them to Mr Corbyn if you think it appropriate.

Trip 2: Tunis (29 September 2014 to 1 October 2014).

- 15 Mr Corbyn earlier sent you an email from the Council for European-Palestinian Relations which suggests that he flew (business class) direct to Tunis with Tunisair on 29 September 2014, and that for his return he flew from Tunis back to London (economy) with Lufthansa, via Frankfurt, very early in the morning of 2 October. It seems that Mr Corbyn did not record the costs of these flights at the time of his visit.
- 20 He has therefore sent you an estimate, based on the higher prices which would be charged in 2018. However, it looks to me as if this estimate was also based on a direct flight home, instead of the flights via Frankfurt. If so I suggest that the cost of the indirect return flights would probably have been higher than he has estimated for direct flights. This may suggest that he therefore ought to have registered this
- 25 visit.

Question 1: Did Mr Corbyn estimate the costs of homeward travel on the basis of a direct flight from Tunis to London?

Question 2: If so does he agree that the flights which he took via Frankfurt were probably more expensive?

- 30 Question 3: Does he wish to review his estimate that this visit fell below the financial threshold for registration?

Trip 4, Basel (4 to 5 July 2014)

Mr Corbyn has pointed out that this visit was to an OSCE conference. Visits organised by the OSCE do not have to be registered. In this case it seems that the visit was organised (and paid for) by Parliamentarians for Nuclear Non-Proliferation and Disarmament, so it would have needed registration if the value exceeded £660.

- 5 Mr Corbyn has provided an e-ticket which covered flights from London to Basel, rail travel from Basel to Zurich, and return flights from Zurich to London. The e-ticket does not bear a price, but Mr Corbyn has estimated this as £298. However, the wording on the e-ticket says it was "issued" on 3 July 2014, the day before he travelled. If this was in fact the date it was bought I suggest that it might have cost  
10 considerably more than the £298 he quotes.

Question 4: Does Mr Corbyn recall whether the air and rail tickets to and from Basel were bought at short notice on the day before he travelled to Switzerland?

Question 5: If they were bought on 3 July 2014, does he wish to revise his cost estimate?

- 15 Trip 7: Western Sahara and Morocco (13 to 17 February 2014)

I think there may have been a slight typographical error, and the cost of the flights would have been £420 instead of £410.87.

- I see that Mr Corbyn left the Western Sahara region on 16 February and arrived at Casablanca that evening, before flying back from Casablanca to London on 17  
20 February. It is not clear whether the hotel costs quoted (£153.91) also include an overnight stay in Casablanca on 16 February.

Question 6: Did Mr Corbyn stay in a hotel in Casablanca on 16 February 2014, and if so were the costs included in the £153.91 quoted for the hotels for the whole visit?

Trip 8, Geneva (20 to 23 April 2013)

- 25 Mr Corbyn did not submit his wife's costs to CND for reimbursement alongside his own, but it appears that she also travelled to Geneva at this time.

Question 7: Can Mr Corbyn confirm that CND did not pay for his wife to travel to Geneva on this occasion in order to support him, or as his guest?

- I hope this is helpful. Please contact me if you think I ought to review this  
30 information again, when Mr Corbyn has replied to you.

**14. Letter from the Commissioner to Rt Hon Jeremy Corbyn MP, 19 December 2018**

5 I am writing today to share with you the letter from the Registrar of Members' Financial Interests, setting out her advice in light of the information you provided at the end of November.

As you can see, she has identified some additional questions about some of your visits. I am conscious that these questions would have flowed more naturally in a conversation or email exchange at the time, and I am grateful to you for the level of detail you have provided since I began my inquiry.

Please let me have a full response to the seven questions Mrs Wood has raised as soon as possible and no later than 10 January 2018.

**15. Letter from the Commissioner to Rt Hon Jeremy Corbyn MP, 9 January 2018**

Thank you for your letter of 19 December 2018.

20 As requested, please find below my answers to the additional questions raised by the Registrar, [name redacted].

**Visit 2 (Tunis)**

1. Did Mr Corbyn estimate the cost of homeward travel on the basis of a direct flight from Tunis to London?

25 No. The outward leg of the flight I took was direct business class flight booked by the organisers with Tunis Air, the return leg was an economy class flight with Lufthansa via Frankfurt.

30 Using standard search engines it has not been possible to find the exact flight (business class outbound and economy return) and so a precise quote cannot be obtained. The flight estimates I provided were based on various internet searches and a range of ticket prices.

5 I included with my response searches for business class flights outbound and economy class inbound - including several via Frankfurt - on the exact same dates (29 September and 2 October) four years later. However, these searches are for single tickets, whereas a return ticket is almost always cheaper. In addition, the prices obtained through these searches obviously do not take into account any discount we believe the Tunisian Government will have received with Tunis Air or by using a travel agency to make block bookings.

2. If so does he agree that the flights which he took via Frankfurt were probably more expensive?

10 In my experience it is not always the case that indirect flights are more expensive than direct flights - indeed the opposite is often true. I believe it depends on demand at the time of booking. Even if the Frankfurt flights were more expensive, it is still likely to have been within the threshold.

15 Enclosed with this letter are additional searches that were conducted on my behalf at the time of my initial response but were not sent because, although they were on the same week days, they were not on the precise dates which corresponded with those on which I originally travelled four years earlier. You may find these additional searches helpful to your inquiry. They demonstrate the fact that indirect flights with Lufthansa could have been cheaper or not significantly more expensive than a direct flight and, in any event, below the figure I estimated.

20 The document entitled "Tunis Flight Estimates 1" shows various business class flights. The document entitled "Tunis Flight Estimates 2" shows various economy class flights.

25 Based on the searches provided and for the reasons outlined above, I believe the estimate I provided for the flights is a reasonable one.

3. Does he wish to review his estimate that this fell below the financial threshold for registration?

30 No. It is my view that the estimates provided for flights, accommodation, transport and food are generous estimate and demonstrate that the trip fell below the financial threshold for registration.

Visit 4 (Basel)

4. Does Mr Corbyn recall whether air and rail tickets to and from Basel were bought at short notice on the day before he travelled to Switzerland?

35 The figure included for my flight and rail ticket was not an estimate but was based on the actual figure included with the ticket. The page with the price of the ticket

was mistakenly not included in my initial response. Please find it enclosed with this letter.

5. If they were bought on 3 July 2014, does he wish to revise his cost estimate?

No

5 Visit 7 (Western Sahara)

6. Did Mr Corbyn stay in a hotel in Casablanca on 16 February 2014, and if so were the costs included in the £153.91 quoted for the hotels for the whole visit?

10 Yes, I did stay in a hotel in Casablanca on 16 February 2014 and the costs were included in the £153.81 quote. As for the discrepancy in the flight costs, we believe the figure of £420 has been reached by adding together the ticket's "airfare" and "total" amounts. However, we were told by the trip's funders that the cost was £410.87. I enclose for your information the breakdown of costs that was sent to me in 2014 regarding this trip.

Trip 8 (Geneva)

15 7. Can Mr Corbyn confirm that CND did not pay for his wife to travel to Geneva on this occasion in order to support him, or as his guest?

This is confirmed. The original enclosure I submitted for Trip 8, Question 4a includes an email to CND dated 16/08/2013 where I clarify that costs for my wife should not be included. I have included it again with this letter.

**16. Letter from the Registrar to the Commissioner, 17 January 2019**

25 Thank you for your letter of 16 January, with which you enclosed one from Mr Corbyn. Mr Corbyn has helpfully provided detailed answers in response to the questions I asked about Trip 2 to Tunis, Trip 4 to Basel, Trip 7 to the Western Sahara and Trip 8 to Geneva.

30 I have considered carefully the information provided about Trip 2 to Tunis. Mr Corbyn has told you that he believes that this visit cost £656, which at the time fell just below the threshold for registration (over £660). I had asked again about the costs of the air tickets bought for him (which, for the purposes of the Register, would

need to be based on the market rates and not on any discounted fares paid by the Tunisian government).

5 If a Member asks us if they need to register a visit whose costs appear very close to the threshold for registration, I would normally ask them how confident they were about the costs of the different elements of it and also whether there might have been other costs (such as taxi fares) which ought to be included. Sometimes this prompts the Member to revise their estimate and to register the visit. In response to my questions Mr Corbyn has told you that he remains confident in the costs he has given you ("I have seen no evidence, information or reason to undermine my original estimate" ), that he believes that he believes the estimates for flights, accommodation , transport and food are "generous" and that he believes his initial estimate of £410 for the airfares was "reasonable". Clearly it is harder to establish the value of a visit four years later, and in the absence of records. But I can say that - in the absence of other evidence - if Mr Corbyn had made these comments to us in 15 2014, about a visit which he believed cost £656, we would not have advised him to register that visit.

Mr Corbyn's answers in relation to the other three visits satisfy me that, on the basis of the information now provided, we would not have advised him to register these.

**17. Letter from the Commissioner to Rt Hon Jeremy Corbyn MP, 4 February 2019**

25 I wrote to you on 16 January 2018 to say that I was seeking the advice of the Registrar of Members' Financial Interests about your letter of 9 January 2019. I have since received her reply (copy enclosed).

I now have sufficient information to reach decisions on the allegations that you have acted in breach of the rules on registration of Members' financial interests.

30 During my inquiry I have focused on overseas visits you made between 2011 and 2014. I am grateful to you and to your office for the evidence provided, including material to support the estimates you have made.

Decisions

35 As you have already acknowledged, you should have registered your visit to New York in April 2014 because it was funded by CND and of a value greater than £660 (£859). Your failure to do so at the time was a breach of paragraph 13 of the then Code of Conduct for Members.

I do not uphold the complaint in respect of the other 16 visits listed in the annex to your letter to me of 10 October. Based on the evidence you have provided, (using your numbering) I accept that:

- 5
- Seven visits (visits 3, 5, 10, 11, 12, 15 and 17) were entirely self-funded and did not require registration
  - One visit (visit 14) was wholly funded through UK public funds, and two more (visits 1 and 13) were partially self-funded and partially paid for through UK public funds and did not require registration
- 10
- One visit (visit 16) was funded by the European Parliament and the rules did not require its registration
  - One visit (visit 8) was partly funded by CND and partly self-funded. The Registrar has told me that she has no evidence that, at the relevant time (April 2013), Members would have been advised to register a visit if partially self-funded when the costs met by the third party (or parties) did not exceed the then threshold of £660.
- 15
- The information you have provided about the value of the funding for the remaining four visits (visits 2, 7, 4 and 9) indicates that three of the visits were significantly below the then threshold for registration of £660 (visits 4, 7 and 9). On that basis, the rules would not have required their registration.
- 20
- The fourth visit (visit 2) to Tunisia from 29 September to 1 October 2014 was, by your estimate, very close to the threshold at £656. We have corresponded about the basis for your estimate and you have provided answers to questions the Registrar thinks it is likely she would have asked you had you consulted her about registering this visit in October 2014. On the basis of that correspondence, I do not uphold the allegation of a breach of the registration rules in respect of that visit.
- 25

30 I asked you to consider, at the beginning of this inquiry, whether there had been any occasion when the rules of the House would have required you to make a declaration of interest. You have given me an assurance that you have checked and, as far as you are able to ascertain, there was not. You have also told me that you have never engaged in lobbying to secure an exclusive benefit for the Tunisian Government, or its clients or for CEPR.

35 In the absence of any specific allegations by the complainants, the single breach of the registration rules and the assurances you have given, I do not think it is appropriate to investigate any further the question of declaration or lobbying for reward or consideration. On the basis of the evidence I have, I do not uphold allegations of breaches of those rules.



Next steps

Under Standing Order No 150 I may conclude an inquiry without making a referral to the Committee on Standards in certain circumstances, using the "rectification" procedure.

- 5 You have already acknowledged and apologised unreservedly for the breach of the rules identified above. You have also taken appropriate action to correct that breach, by registering your 2014 visit to New York on 29 November 2018. Subject to your agreement to my usual procedure of asking the Registrar to identify the late registration in the Register through the italicisation of the relevant text, I will  
10 conclude this inquiry by way of the rectification procedure.

I would issue a decision letter to each of the complainants and publish a report of my work on my webpages. And, I would report briefly to the Committee that I have concluded the inquiry in this way.

- 15 I enclose a copy of the evidence pack which would subsequently be published on my webpages, to give you the opportunity to comment on its factual accuracy. You will see that I have redacted the personal details of third parties in the supporting evidence you provided. Please let me know if you think any additional redactions are required. There is one item in the pack (see blue flag) which through repeated copying is now barely legible. If you are able to provide a more readable copy, I  
20 would be grateful although this is not critical.

Please let me know whether you accept my analysis and the proposal to conclude this matter by way of a rectification as soon as possible and no later than 18 February 2019.

- 25 In the meantime, this matter remains protected by parliamentary privilege and should continue to be kept in confidence.

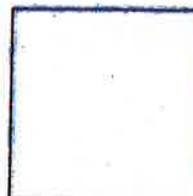

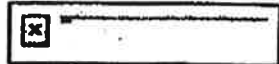
